**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act Relative to Work and Family Mobility During and Subsequent to the COVID-19  
Emergency.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority  
of the same, as follows:*

1           Whereas, Massachusetts residents must be able to travel safely during the declaration of  
2 emergency related to COVID-19 and thereafter, it is hereby declared to be an emergency law,  
3 necessary for the immediate preservation of the public convenience.

5           Be it enacted by the Senate and House of Representatives in General Court assembled,  
6 and by the authority of the same, as follows:

7           SECTION 1. Section 2 of chapter 90 of the General Laws, as appearing in the 2018  
8 Official Edition, is hereby amended by inserting after the words “Social Security  
9 Administration”, in line XX, the following words: proof of lawful presence in the United States  
10 or any other document or combination of documents acceptable under section 8 as proof of  
11 identity and date of birth.

12 SECTION 2. Section 8 of said chapter 90, as so appearing, is hereby amended by striking  
13 out, in lines 275 to 277, the sentence “No license of any type may be issued to any person who  
14 does not have lawful presence in the United States.” and inserting in place thereof the following  
15 sentences:-

16 Persons who do not provide proof of lawful presence, including those who are ineligible  
17 for a social security number, shall be eligible for a Massachusetts license if they meet all other  
18 qualifications for licensure and provide satisfactory proof to the registrar of identity, date of birth  
19 and Massachusetts residency. When processing an application for a Massachusetts license, a  
20 learner’s permit, a Massachusetts identification card, or a motor vehicle registration, the registrar  
21 shall not inquire about or create a record of an applicant’s citizenship or immigration status.

22 SECTION 3. Said section 8 of said chapter 90, as so appearing, is hereby further  
23 amended in lines 278 and 279 by striking out the words “or a Massachusetts license”.

24 SECTION 4. Said section 8 of said chapter 90, as so appearing, is hereby further  
25 amended by inserting before the word “license”, in line 287, the following words:- “REAL ID-  
26 compliant”.

27 SECTION 5. Said section 8 of said chapter 90, as so appearing, is hereby further  
28 amended by inserting after the word “temporary.”, in line 295, the following sentence:-

29 If, at the expiration of the term of a REAL ID-compliant license, the licensee does not  
30 provide proof of lawful presence, the licensee shall remain eligible to apply for a Massachusetts  
31 license.

32 SECTION 6. Said section 8 of said chapter 90, as so appearing, is hereby further  
33 amended by adding the following paragraphs:-

34 For applicants for a Massachusetts license under this section or section 8B who do not  
35 provide proof of lawful presence in the United States, the registrar shall accept the following  
36 documents as proof of identity and date of birth: 1 document from list A, as described in this  
37 section, or 2 documents from list B, as described in this section; provided, that if an applicant  
38 presents 2 documents from list B, at least 1 document shall include a photograph of the applicant  
39 and at least 1 document shall include the applicant's date of birth.

40 List A:

41 A foreign passport that is unexpired or that expired no more than 5 years before the date  
42 of application; or

43 A consular identification document that is unexpired or that expired no more than 5 years  
44 before the date of application.

45 List B:

46 A driver's license from any United States state or territory that is unexpired or that  
47 expired no more than 5 years before the date of application;

48 An identification card issued by the registrar under Section 8E that is unexpired or that  
49 expired no more than 5 years before the date of application;

50 An original or certified copy of a birth certificate; or

51 An Employment Authorization Document issued by United States Citizenship and  
52 Immigration Services that expired no more than 5 years before the date of application.

53 Each applicant for a license or learner's permit under this chapter shall attest under the  
54 pains and penalties of perjury that their license or right to operate has not been suspended or  
55 revoked in another state, country or jurisdiction.

56 SECTION 7. Section 8B of said chapter 90, as so appearing, is hereby amended in lines  
57 42 to 44 by striking the words “, except that no permit shall be issued to an applicant for a period  
58 of time longer than the registrar determines the applicant is legally authorized to remain in the  
59 United States”.

60 SECTION 8. Section 8E of said chapter 90, as so appearing, is hereby amended by  
61 inserting, after the sentence ending on line 45, the following sentences:-

62 Persons who do not provide proof of lawful presence, including those who are ineligible  
63 for a social security number, shall be eligible for a Massachusetts identification card if they meet  
64 all other qualifications for a Massachusetts identification card and provide satisfactory proof to  
65 the registrar of identity, date of birth and Massachusetts residency. When processing an  
66 application for a Massachusetts identification card, registrar shall accept any document or  
67 combination of documents acceptable under section 8 as proof of identity and date of birth.

68 SECTION 9. Said section 8E of said chapter 90, as so appearing, is hereby further  
69 amended by inserting, before the words “identification card” in line 48, the words “REAL ID-  
70 compliant”, and by striking out, after the words “identification card” in line 48, the words “of  
71 any type”.

72 SECTION 10. Said section 8E of said chapter 90, as so appearing, is hereby further  
73 amended by striking out, in line 51, the words “an identification card” and inserting in place  
74 thereof “a REAL ID-compliant identification card”.

75 SECTION 11. Said section 8E of said chapter 90, as so appearing, is hereby further  
76 amended by inserting, before the words “identification card” in line 60, and again before the  
77 words “identification card” in line 62, the words “REAL ID-compliant”.

78 SECTION 12. Said section 8E of said chapter 90, as so appearing, is further amended by  
79 inserting, after the sentence ending on line 68, the following sentence:-

80 “If, at the expiration of the term of a REAL ID-compliant identification card, the card  
81 holder does not provide proof of lawful presence, the card holder may apply for a Massachusetts  
82 identification card.”

83 SECTION 13. Section 30 of said chapter 90, as so appearing, is hereby amended by  
84 inserting after the third sentence the following sentences:-

85 The registrar shall not keep any document or any copy of any document received or  
86 presented in the course of an application for a Massachusetts license, Massachusetts  
87 identification card, or registration used to prove identity, date of birth, residency, social security  
88 number, or lack of or ineligibility for a social security number after such license or registration  
89 has been issued. A proper record shall not reveal information about the documents received or  
90 presented in the course of an application for a Massachusetts license, Massachusetts  
91 identification card, or registration, including what type of documents were used to support the  
92 application.

93           SECTION 14. Said section 30 of said chapter 90 is hereby further amended by adding the  
94 following paragraph:-

95           Except as required by state or federal law, the registrar shall not sell, disclose, or permit  
96 access to records kept by the registrar, including, but not limited to, personal identifying  
97 information, communications between applicants and the registrar, photographs, images, and  
98 biometric information. Records that are not otherwise required to be disclosed under state or  
99 federal law shall be disclosed only pursuant to a judicial warrant.

100           SECTION 15. This act shall take effect in 90 days.
